PRISON CONDITIONS

Government to probe mass assault: The Sunday Tribune reported that the Department of Correctional Services finally agreed to investigate Correctional Services officials allegedly involved in an incidence in which 'prisoners were taunted, sprayed with water and beaten with batons, shock boards, broomsticks, pool cues and pickaxe handles'. The United Nations Human Rights Committee found that the Department's officials had indeed tortured Bradley McCullum, an inmate of the St Albans Maximum Correctional Facility in Port Elizabeth, during a mass assault on prisoners. Department of Correctional Services faces an increase in civil claims: Business Day reported that the potential for civil claims against the Department of Correctional Services was now larger following an increase in the number of assaults in prisons over the past three years. According to statistics made available to the Parliamentary Committee on Correctional Services, figures for assaults skyrocketed from 83 per every 10 000 prisoners in September 2008 to 137.7 per every 10 000 prisoners in October 2009. In November 2010, there were 317 assaults per every 10 000 prisoners in correctional facilities.
