**Plans to build prefabricated prisons:** IOL reported that the Minister of Correctional Services has informed parliament of the Department's plans to build "high-rise" or "prefab" detention facilities. The library charges an annual membership fee of CAF 5000, and food and health care is extremely limited for those who cannot pay for it themselves. During the attempt, 967 prisoners escaped, 152 of which were reportedly recaptured shortly thereafter.
