Allegations of human rights abuses in remand detention facility: Politics Web reported that there is much "cause for

The nature of the abuses suffered by the remand detainees are reportedly torture, assault, bribery and corruption, unhygienic living conditions and the denial of visitation rights. Allegations of torture and ill-treatment in Rwandan prisons: Jambonews reported that the 8 Sierra-Leoneans sentenced by the Special Court for Sierra Leone and serving their sentence in a special prison in Rwanda complained that they were suffering torture and ill-treatment, including beatings, a lack of access to food and medical services, death threats and forced labour. Following these allegations, the Special Court visited the prison and the Rwandan authorities, who denied the allegations.
