3	TRESPASS	Can be accepted	Guilty (withdrawn & not guilty must be considered)
4	MALICIOUS DAMAGE TO PROPERTY	NO	Guilty (withdrawn & not guilty must be considered)
5	ASSAULT	NO	Guilty (withdrawn & not guilty must be considered)
6	FRAUD	NO	Guilty (withdrawn & not guilty must be considered)
8	HOUSE BREAKING	NO	Guilty (withdrawn & not guilty must be considered)
9	COMMON ROBBERY	NO	Guilty (withdrawn & not guilty must be considered)
10	TRAFFIC OFFENCES	NO	If over 5 years can be accepted and after 10 years they must apply for expungement
11	IN POSSESSION OF NACOTICS	NO	Guilty (withdrawn & not guilty must be considered)

- *Crime is a serious monster in our country and for the protection of our children the Federation has a child protection policy that is enforced by making **police clearance / name clearance a pre-requisite** for all candidates that would like to acquire, hold and make use of a SSA teaching or coaching credentials.*
- A police clearance / name clearance document that lists any of the above crimes with a **guilty verdict** means that those applicants **should not** be accepted for training on ANY SSA training course.
- If the verdict shown is older than **10 YEARS** then the person must apply for an expungement and get clearance before they can attend any SSA training.
- **Expungement EXCLUDES, RAPE OR ANY OTHER SEXUAL ASSAULT and ASSAULT.**
- All police clearances are vetted by SSA before communication is send to affiliates.
- ADMISSION OF GUILT - THE OFFENCE WILL APPEAR ON THE POLICE CLEARANCE
- ANY DOUBT AT ALL CHECK WITH SSA HEAD OFFICE
- OFTEN CANDIDATES CAN BE ASKED TO APPLY FOR A FULL POLICE CLEARANCE
- PENDING CASES - CANDIDATES WILL HAVE TO WAIT FOR THE FINAL VERDICT AND WILL NOT BE ALLOWED ON ANY SSA COURSES
